## Regulation no. 2/2022 of the Warsaw University of Technology Rector of 20 January 2022

on introduction of the price list for reprographic and information services and the amounts of fees for failure to return library documents within the specified time limit at the Warsaw University of Technology Main Library

Pursuant to § 3 section 2 and section 3 point 1 of the Regulations of Access to the Collection and Provision of IT Services of the Library and Information System of the Warsaw University of Technology, constituting an annex to Resolution no. 160/L/2021 of the WUT Senate of 22 December 2021 on adoption of the Regulations of Access to the Collection and Provision of IT Services of the WUT Library and Information System, it is resolved as follows:

§ 1

In case of failure to return the borrowed library documents within the specified time limit, a fee shall be payable to the amount of PLN 0.30 for each day of the delay.

§ 2
