Generating Statement 3 with a list of accomplishments

Persons pursuing research activities in a two disciplines



Pursuant to the Rector's Regulations No. 4/2020 of 29/01/2020 and No. 7/2020 of 5/02/2020, persons conducting scientific activity at the Warsaw University of Technology are required to submit a declaration authorizing the Warsaw University of Technology to list their achievements within the specific disciplines indicated in the declarations No. 1 and No. 2. The declaration shall be submitted by 31 January each year. The statement shall be accompanied by a list of scientific achievements achieved during the period of employment at the Warsaw University of Technology, generated from the Knowledge Base of Warsaw University of Technology, in accordance with the specimen given in Appendix 3 to the Regulation.



Logging into Knowledge Base of PW

1. Go to the PW Main Library website, go to the PW Knowledge Base tab, and then log in by entering your data:
 - **ID** – employee's email address (if entered in USOS) or PESEL number
 - **Password** - the same as the one used to log in to the USOSWeb system



Searching for the author profile in the Knowledge Base




